- 1. <u>Purpose</u>. To provide guidelines and procedures for the Naval Amphibious Base Little Creek (NAVPHIBASE LCREEK) Sailor of the Year/Quarter (SOY/SOQ), Junior Sailor of the Year/Quarter (JSOY/JSOQ), and Blue Jacket of the Year/Quarter (BJOY/BJOQ) programs.
- 2. Cancellation. NAVPHIBASELCREEK/REGPUBSAFETYINST 1700.2.
- 3. <u>Background</u>. Per reference (a), the Chief of Naval Operations (CNO) established the SOY Program in 1972 and further expanded the program to recognize the very best Sailors in paygrades E-1 through E-6. References (a) and (b) provide guidance and procedures for program implementation and management.
- 4. <u>Discussion</u>. The policy of the Commanding Officer, in support of the CNO, is to exploit every opportunity to recognize NAVPHIBASE LCREEK Sailors for superior performance, exemplary personal conduct, leadership, self-improvement, command/community involvement, and appearance. To recognize all outstanding personnel, Sailors will be recognized in the following categories:
 - a. SOY/SOQ (paygrade E6).
 - b. JSOY/JSOQ (paygrades E4 or E5).
 - c. BJOY/BJOQ (paygrades E1 through E3).

This program provides an equitable means to select NAVPHIBASE LCREEK's "best of the best" for public recognition in a competitive environment commensurate with each individual's level of expertise and leadership skills.

5. Eligibility

- a. All permanently assigned Sailors attached to UIC's 61414 and 40191 will compete for selection under below programs as follows:
- (1) SOY Sailors in paygrade E-6 meeting the eligibility requirements stated in references (a) and (b).
- (2) JSOY Sailors in paygrades E4 or E5 demonstrating those traits and characteristics stressed in paragraph 7 below (Selection Criteria).
- (3) BJOY Sailors in paygrades E-1 through E-3 demonstrating those traits and characteristics stressed in paragraph 7 (Selection Criteria).
- b. All permanently and Temporary Additional Duty assigned NAVPHIBASE LCREEK Sailors attached to UIC's 61414 and 40191 will compete for selection under below programs as follows:
- (1) SOQ Sailors in paygrade E-6 meeting the eligibility requirements stated in references (a) and (b).
- (2) JSOQ Sailors in paygrades E4 or E5 demonstrating those traits and characteristics stressed in paragraph 7 below (Selection Criteria).
- (3) BJOQ Sailors in paygrades E-1 through E-3 demonstrating those traits and characteristics stressed in paragraph 7 (Selection Criteria).

6. Procedures

a. SOY/JSOY/BJOY Program

- (1) Each department may submit one nomination package (enclosures (1) through (3) as applicable) to the Command Master Chief (CMDCM) no later than 15 December of the applicable calendar year.
 - (2) The CMDCM will convene the selection board during the

second week of January. Selection board membership will consist of all Department LCPO's, chaired by the CMDCM.

- (3) The CMDCM will submit selection board results to the Commanding Officer, via the Executive Officer, for approval no later than two days following board adjournment.
- (4) The CMDCM will mail the NAVPHIBASE LCREEK SOY nomination package to Commander, Navy Region, Mid-Atlantic (CNRMA) no later than the prescribed due date as determined by CNRMA.

b. SOQ/JSOQ Program

- (1) Each department/division may submit one nomination package for each category (enclosures (1) and (2)) to the CMDCM no later than Friday of the first week of each quarter (i.e., first Friday of January, April, July, and October) for the previous quarter's performance.
- (2) The CMDCM will submit selection board results to the Commanding Officer, via the Executive Officer, for approval no later than two days following board adjournment.

c. BJOQ Program

- (1) Each department/division may submit one nomination package (enclosure (3)) from paygrades E-1 through E-3 based on selection criteria of paragraph 7 below.
- (2) Department/Division LCPO/LPO's will convene the selection board during the second week of each quarter. Selection board membership will consist of First Class Petty Officers or Chief Petty Officers, chaired by the CMDCM.
- (3) The Department LCPO/LPO's will submit selection board results to the Commanding Officer, via the Executive Officer and the CMDCM, for approval no later than two days following board adjournment.
- 7. <u>Selection Criteria</u>. To reward continued improvement, the nomination process should stress actions completed during the period being considered. Selection boards will use the appropriate nomination package and enclosure (5) to evaluate candidates. The process will stress:
- a. Demonstrated sustained superior performance in rate and leadership skill.

- b. Exemplary personal conduct, on and off-duty.
- c. Exceptional performance in general duties not associated with primary duties (e.g., watch standing, collateral duties, etc.)
 - d. Self-improvement (professional and personal).
- 8. Recognition. The following awards and benefits shall be presented for selectees of the following programs:

a. SOY/JSOY/BJOY

- (1) Navy and Marine Corps Achievement Medal.
- (2) SOY/JSOY/BJOY plaque (as applicable).
- (3) SOY/JSOY/BJOY parking pass (as applicable).
- (4) Reserved parking at the local Navy Exchange and Commissary.
 - (5) Four Day Special Liberty.
- (6) NAVPHIBASE LCREEK name-tag identifying them as the SOY/JSOY/BJOY (as applicable).
- (7) Hometown news release (prepared by the department and submitted to 00PA).
- (8) Picture displayed on the Quarterdeck of NAVPHIBASE LCREEK (Bldg 1602).

b. S00/JS00/BJ00

- (1) Letter of Commendation (sample provided at enclosure (4)).
 - (2) SOQ/JSOQ/BJOQ engraved plague (as applicable).
 - (3) Three Day Special Liberty.
- (4) Reserved parking at the local Navy Exchange and Commissary.
- (5) NAVPHIBASE LCREEK name-tag identifying them as the SOQ/JSOQ/BJOQ (as applicable).

- (6) Hometown news release (prepared by the department and submitted to 00PA).
- (7) Picture displayed on the NAVPHIBASE LCREEK Quarterdeck (Bldq. 1602).
- 9. Coordination Responsibilities. The CMDCM is responsible for notifying board members of the time and location of the board meeting, coordinating arrangements for ceremonies, assisting departments in preparing nomination packages for submission to higher authority, and overall conduct of this program and associated activities. The parent department is responsible for notifying the nominee and insuring their presence at the time specified and in the proper uniform.
